There is also darkish brown substance in another plastic bag and part of a marijuana pipe. A small lamp that is in the shape of a skull or several skulls with that general theme all around. Above that is a stuffed caribou head, hanging off of that head is a caricature of an Indian with some sort of a dragon's head on top of that, has an Indian headdress with feathers, hanging off of those antlers, also.

Continuing clockwise now against the south wall, there is another picture window looking out to the south. The vertical blinds here are closed up. There is another shelving on top of this window. This has similar bric-a-brac. Located on top of that shelf there is a pair of snakeskin cowboy boots, children's type, a stuffed teddy bear, small speaker, a railroad engine, figurines, a small panda bear, a small globe, a buffalo figurine.

The couch down below that has a tannish colored cover on top of the couch, has a horse themed blanket on the back, a reddish, tan and black pillows on the sides. There is, what appears to be, a couple of camera bags on the west end of the couch, closed up. There is also a charger for some sort of battery in the middle part of the couch. Over on the east end of the couch, on one of the cushions, there are, at least, four drops of, what appear to be, blood and some blood transfer. There is also a defect with a grayish swipe on it that is, possibly, a bullet strike onto the cushion, itself. On the rug, in front of the cushion, there are several more blood drops/blood transfer onto the rug. There is also a bullet at, appears to be, heavily deformed that is an the rug next to one of the large drops of blood. Also, another bullet fragment just in front of the couch by where the blood drops on the couch cushion are located.

I was contacted by Officer John DAILY in reference to a homicide call-out at, approximately, 2115 hours.

Once on the scene I was tasked to start videoing the outside of the scene until the search warrant was applied for and granted.

First image on the recording will be of the photo log stating the case, date, and the address which is

Second video frame is going to be of me standing at the T intersection of 12th and Friendly. The video starts out with me facing the residence, and doing a three-sixty in the middle of the intersection, video scan just east of the residence in the intersection and then it ends facing again where I started which is the residence, itself.

I then walked northbound on 12th Avenue towards the front driveway of the residence, again, still outside of the residence, video taped the front and general observations, there is a blue colored Ford Taurus, plate EJP390 parked in the driveway, as well as, what looks to be, a Jeep Cherokee, dark in color, plate EAA522. Also, noted on the property is, what appears to be, two RV's that are parked in-between residences and looks like two covered motorcycles, also in the driveway.

Proceeded walking up the driveway of the residence through the front sidewalk into an arctic entry. The arctic entry has glass sliding doors that go into the residence, itself.

I then entered the glass doors. The glass door entrance leads to a dimly lit dining room. General observations, dining room table with metal Chinaware and fruits, numerous personal photographs on the walls. Seems to have an Indian motif as there are Indian decorations or Native decorations, as well as commemorative plates and ornaments. Also, on the dining room floor is, what appears to be, a glass top from a table, moved here and placed on the kitchen floor, possible marijuana

cigarette, as well as, what appears to be, marijuana pipes and paraphernalia on the table, itself.

To the left of the dining room is an open kitchen. General observations within the kitchen, itself, there is a blue sofa that appears to have been moved into the kitchen. At the foot of the sofa there is a NASCAR heart shaped tin, containing chocolates in the shape of NASCARS that have spilled onto the floor. There is, also, a magazine holder and it is in the shape of a reclining cowboy and that appears to, also, have been moved, possibly, from the living room into the kitchen, as it is blocking the general path of walking. There is a black garbage bag in the middle of the kitchen floor, as well as a heart shaped key that is on the floor next to the garbage bag.

Continuing left through the kitchen you come into a little alcove where a bar has been set up. General observations, lots of collectibles in the shape of skulls and skeletons, knives and daggers. There are pelts of animals.

From the bar/alcove, continued walking straight into the actual living room. General observations of the living room, again, keeping with the general motif, lots of Indian and country western type of collectibles, lots of skull figurines. The sectional for the blue couch that is in the kitchen is also in the living room. There is a beige colored couch. On the couch, itself, appears to be, what is, possibly, a bullet hole and bloodstains next to the bullet hole. In front of that couch, on another piece of carpet, there, again, appears to be bloodstains. There is a woman's purse lying on the floor, as well as a pair of small collapsible scissors with a skull keychain attached to it. Next to the couch, with the bloodstain and the bullet hole, is a pair of men's blue jeans with bloodstains and, what appear to be, possibly, bullet holes and they appear to have been cut off when they were removed from the victim. The living room circles back into the entrance to the kitchen and the dining, and there is a closet, also, located in the living room.

Came back out of the living room, back into the dining room, continued walking down the dining room hall to a bathroom. Same particular motif with western style artifacts and frames and pictures.

The washer and dryer are located in the bathroom, also.

From the bathroom I continued walking down the hall to another room. General observations of this room is it appears to be like a hobby room of sorts with two boxes, a working desk and looks like numerous projects and items of hobby.

Exiting that room, I go back to the hallway and entered, what appeared to be, the master bedroom. Near the bed there, appears to be, a marijuana pipe that is filled with marijuana, but does not appear to have been smoked. There are two separate safes in the bedroom. It is dim lighting. There is a gun cabinet with numerous rifles and pistols. There is also a bathroom connected to this bedroom with personal hygiene items.

From this bedroom we go back to the hallway and enter another room where there is, what appears to be, like a storage room of sorts with numerous items, including a dresser, boxes, movies and personal items of such.

After having concluded taking videos of the residence, I was assigned to take photos of the inside of the residence.

3. Took several photographs of men's jeans with, what appeared to be, bullet holes in them and bloodstains. These jeans were, again, located next to the beige couch on the south wall.

4. Next series of photos, of the beige couch located on the south wall. Took overall photos and then close-up photos of, what appears to be, a bullet hole on one of the cushions. The cushion further to the east wall and two bloodstains next to it.

5. Next series of photos, bloodstains, as well as a <u>discharged bullet</u> that is <u>deformed</u>, located in front of the bloodstained couch, as well as in front of the bullet hole in the couch.

1. Next series of photos is, again, going to be of the couch and the discharged, sperit round that is in front of it.

2. The bloodstain that is directly north of the bullet and looks like a meth pipe with a lighter that is directly east of the bullet, as well as the couch.

- 3. A woman's gray purse located on the floor along the couch that is located on the east side, as well as marijuana paraphernalia routinely used by growers or smokers, found on the floor, also, that has a skull key tag to it.
- 4. Men's glasses, again, located on the blue colored couch on the east wall.
- 5. A brown wooden jewelry box type. Inside is, what appears to be, drug paraphernalia envelopes with some green powder, as well as, what might be, tar heroin or possibly marijuana hash. This was located in a little end table to the east of the beige couch.
- 6. A small Tupperware container with, what appears to be, marijuana shake in it, and it was sitting on top of a larger wood like container that, when opened, contained numerous smoking paper packages.
- 7. Another wood like container that was, again, on another end table, glass end table located on the east wall, just north of the blue sofa. The box contained marijuana pipes and drug paraphernalia.
- 8. Next series of photos are of the entertainment center located on the north wall of the living room. Located on the west side of the

entertainment center was a digital palm scale, as well as a larger scale in a box.

Having concluded taking general photos of the living room area, I then proceeded to the alcove where the bar is located and that is going to be on the north side of the residence. Once having taken general photos of the bar area a strong smell of marijuana from a wooden container, located on top of the bar, upon opening the wooden container I discovered a bag of marijuana and other containers containing some green substance, as well as some marijuana pipes. Photos of that were taken.

I then noted a strong smell of green marijuana coming from two Crown Royal bags that were hanging inside of the bar. Upon looking into the Crown Royal bags again marijuana buds were also discovered. The following are photos of that.

Located under the bar stools, on the inside of the bar, was a brown and beige duffle bag with, what appeared to be, the same type of bag that was found two packages of the marijuana in the wooden box on the bar. Upon opening the container it did contain empty, what appears to be, marijuana bags, as well as a scale used to weigh pounds.

The next series of photos are photos of the bag.

The next series of photos are of electric bills from Chugach Electric and these bills are in reference to as well as both coming back to the same residence or at least under the same account number for the residence, as well as an address on the three of which, showing extremely large amounts or knowatt usage per month consistent with a possible marijuana grow. Photos of the bills were taken.

NOTIFICATION

On 2-12-2007 at approximately 2022 dispatch advised via the alert tone of a shooting in the area of 11th Avenue and Friendly Street, the address was later corrected to the shooting occurred, dispatch advised they were getting information of a male who has been shot "at least 3 times".

ARRIVAL/OBSERVATIONS

Upon arrival at the residence I observed numerous APD Officers and Anchorage Fire Department Rigs on scene, the medics were loading the victim into the ambulance and en route to the Alaska Native Medical Center code -3 (lights and sirens), I went en route with the medics.

Upon arrival at the hospital the victim, later identified as TERRY TUMBLESON SR (2-1-1955) was taken from the ambulance and rushed into the emergency room where doctors and nurses began working on him, a short time later, at approximately 2058 they advised that he had expired.

ACTIONS TAKEN

I took overall photographs of the victim, he had a wound in the center of his chest and also a wound on the left flank of his back and his left buttock, the rest of the wounds consisted of entrance and exit wounds to the groin area that appeared to exit out the lower legs. Photographs were taken with a Canon Digital XT Rebel on a digital media card, with and without a scale, the media card was turned into property and evidence at the end of shift.

While rolling TUMBLESON to look for more wounds the nurse and doctors handed me an expended round, it appeared to be either .45 or .44 caliber and they stated that it had been found on the hospital bed, I took custody of the round and logged it into property and evidence along with some jewelry that was removed from TUMBLESON.

- (1) 44 or 45 caliber bullet, evidence tag # 741259.
- (1) Silver Neckiace, evidence tag # 741260.
- (1) Gold Necklace, evidence tag # 741262
- (1) Gold Pendant, evidence tag # 741261
- (1) Gold Nugget Cross, evidence tag # 741263

The above items were turned into property and evidence at the conclusion of my shift.

ADDITIONAL INFORMATION

While taking photographs of TUMBLESON at Alaska Native Medical Center, several family members stepped in to the emergency room to view TUBMLESON'S body and make a positive ID, one of the males (who stated that he was TUMBLESON'S son) asked if it was TODD TIX who shot TUMBLESON, when I stated that we did not know yet he advised to look for TIX in "Nancy Lake".
